IMMANUEL LUTHERAN CHURCH, ELCA 2022 ANNUAL MEETING MINUTES – WEDNESDAY, JANUARY 25, 2023

President Robby Grendahl called the 2022 Annual Meeting to order at 6:30pm. Pastor Nate Loer welcomed everyone and gave an opening devotion.

Officers Reports: The 2021 Annual Meeting minutes were accepted as written. Motion made by Kent Schmidt to approve the minutes and seconded by Sharon Boline. Motion carried. Reports including President, Treasurer and Consolidate Balance Sheet were reviewed. Correction of Consolidated Balance Sheet should reflect 12/31/22. Motion made by Rick Johnson and seconded by Margie Anderson. Motion carried.

Financial Review were reviewed. Motion made by Deb Andrews, seconded by Terry Olson. Motion carried.

Rostered Staff Reports: Pastor Nate thanked Robby Grendahl for his service and leadership over the last year and presented an outgoing gift. He also thanked outgoing council members, the current staff members, musicians, choir members and Wednesday worship team. He expressed the congregation excitement for the new role of Elana Seibert as Youth/Family/Education/Spiritual/Gifts Coordinator. He and his wife are thankful for congregational support and prayers for their daughter's recent health issues. Motion made by Sara Grabe to accept rostered reports. Seconded by Sally Adams. Motion carried.

Committee Reports: There were no discussions or corrections to the Worship & Music, Finance, Congregational Life, Property Management, Outreach/Evangelism, Youth reports. No Parish Education report. Motion made by Nate Loer to accept committee reports. Seconded by Deb Haraldson. Motion carried.

Other Reports: There was no discussion or corrections to the Immanuel Church Women, Women's Financials, Lutheran Men's Ministry, Memorials, or Mission Endowment reports. Motion made by Kent Schmidt to accept all other reports. Seconded by Jennifer Brunsberg. Motion carried.

Synod Report: Letter from Bishop Tesch: reviewed. Did not require a motion.

Old Business: No old business.

New Business: Presentation and Adoption of 2023 Budget: Kent Schmidt. Budget decreased due to projected decreased donations and one pastor church model. We increased benevolence and program budgets. We added Youth/Family/Education/Spiritual Coordinator with benefits. Increased our Pastoral compensation by 10% to keep competitive and to compensate for expected increased duties. Increased operating expenses including staff compensation as expected with inflation. We are able to make these increases due to changing to a one pastor model. Motion made by Deb Andrews to accept 2023 budget. Seconded by Iona Fiskum. Motion carried.

Nomination Committee: Education Committee is only one year term as it was not filled last year. No nominations made for open slots in Education Committee, Outreach Committee or two slots on Nominating Committee. Motion made to close nominations and allow church council to appoint members. Motion made by Warner Luoma to accept the slate of council members. Seconded by Margi e Anderson. Motion carried.

Jennifer Brunsberg, the new President, took office and thanked Robby for his leadership during the past year.

The meeting adjourned at 7:11pm with a closing prayer and the Lord's Prayer. A motion was made by Rick Johnson to adjourn and seconded Jane Erckenbrack. Motion carried.

Grace and peace to you, dear people of Immanuel, in the name of our Lord, Jesus Christ.

By my math, this is now the 12th opportunity I have had to share my thoughts in your annual report. I give thanks to God for the many years I've had to journey alongside you and serve as your pastor. Let us spend a couple minutes reflecting on 2023 and looking ahead to 2024.

Of course, the core of what we do is worship God: Father, Son, and Holy Spirit. And 2023 was another strong year of worship. Our numbers could always be stronger, of course. But we continue to see our Sunday worship numbers grow and our Wednesday worship has proven very popular with young families. And many continue to connect with us through the radio and through our YouTube live stream.

2023 was a year of renewed Christian education. Our 8am "Early Risers" Sunday class was quite exciting in the winter and spring of 2023 as we studied the gospel of Matthew. And a "Roots of our Faith" class on the Lutheran Confessions was well received this fall. Both classes were available in person or via Zoom. Our monthly Women's Bible Study is quite well attended. And on Wednesdays, we have had so many great volunteers step up to teach and serve in other ways. We have 5 classrooms on Wednesday night engaging 50+ kids in Christian Education. Combined with a weekly meal and a "learning laboratory" style of worship, we truly have a wonderful model of discipleship for all ages emerging on Wednesdays!

2023 was also another great year of generosity. Year after year, thanks to God's faithfulness, the congregation's generosity, and careful planning from our finance team, Immanuel does a tremendous job of staying financially healthy. And Immanuel is also very generous in the community. The Giving Tree and the WDC Backpacks program continue to be signature programs of Immanuel's work in the community. But we also stay active in supporting many other ministries in our community, region, and world, including Lutheran Social Service, Luther Crest Bible Camp, the Food Shelf, Lutheran Immigration and Refugee Service, and more.

2023 was a year to welcome new staff and welcome old staff to new positions. In January, Elana Seibert, our Administrative Secretary since 2016, was hired as our Youth, Family, Education, and Spiritual Gifts Coordinator. And in February, Tracy Church was hired as our Administrative Secretary. They join an already stellar staff. We look forward to serving the people of Immanuel in 2024.

In the year ahead, I hope God will give our staff, council, and committees wisdom in setting ministry priorities and the strength to achieve those goals. I mostly hope that God will be at work in and through all the people of Immanuel and bless us to share Jesus with our community and world. May God guide us and bless us as we seek to be his people in 2024.

REPORT OF THE WORSHIP & MUSIC COMMITTEE

The Immanuel Worship and Music Committee was very busy again in 2023. The most exciting highlights were:

On April 23, 2023, in celebration of our newly restored Steinway grand piano, Immanuel was honored to have the Taggart Siblings perform a world class concert. The Taggart siblings performing were Emma (20), Jacob (16), Cecelia (10), and Sophie (6). They have performed all across the United States, and Emma and Jacob have performed in several countries worldwide. A free-will offering benefited the Lutheran Disaster Response's US Tornado Relief Funds. The concert was AMAZING!

On October 15, 2023, Immanuel had the pleasure of hosting a Celebration of Music concert in celebration of our pipe organ's 10th anniversary and Immanuel's delayed 85th anniversary. The concert featured Elliott Sander, organist/pianist of Tacoma, Washington, and Alex Swanson, organist/pianist of Fargo, North Dakota. A pop-up choir performed a number during the concert, featuring soloist, Suzanne Moe, and was directed by Alex Moe. A free-will offering benefited the Wadena Area Food Shelf. This was another AMAZING concert, and we were honored to be able to feature our musical instruments here at Immanuel.

Some other highlights of 2023 were:

The Sanctuary Choir sang twice a month for the months of January through May, and September through December; other musicians provided special music occasionally; again in 2023, portions of the Holden Prayer Service format were used for Lenten services, and members of the Worship and Music Committee provided the accompanist and led the music portion of the services; cantors were a part of some Sunday services. Sunday morning worship has shown increased attendance; Communion continues every Sunday, and the first Wednesday of the month; Wednesday evening worship and discipleship has been very successful through 2023 (the kids enjoy the "spontaneous" acolyting, being the Psalmist, and ushering; various formats were used for Wednesday services; Youth Sunday's have been very successful; we transitioned from Facebook Live to YouTube for our live streaming on March lst; the live stream team increased from two to four people; we found a temporary fix (small computer) for the bells, which had quit working; we received a memorial plaque from the school, written by Diana Olson, in memory of Midge Forsness. This plaque is currently displayed outside the Sanctuary by the photo album featuring the restoration of the Steinway grand piano.

As 2023 comes to a close, I am reminded of how very blessed I am to be a part of the Worship and Music Committee; the entire Immanuel family; as well as my own family and friends. My thoughts are summed up by a Kelly Clarkson song (Blessed). Please Google it.

Our Youth Leadership Team works hard to plan events and fundraising opportunities for all the youth of Immanuel. This group currently meets the first Wednesday of every month in the Teen Vibe room and is assisted by Elana Seibert (Youth and Family Education Coordinator) and the Youth Committee Chairperson.

The youth led Sunday worship services in January, May, and October. They also led the Lenten service on March 29th along with serving the meal that evening. In January, March and September the group held Nooma Nights for 9th - 12th graders. Nooma Night provides youth an opportunity to watch a short video and discuss their faith. It is also a great time for fellowship, food, and games. The youth hosted a skating day on Sunday, February 19th, for all families at Pat and Tracy Hegerty's. It was a fun day of skating and food. The youth also provided a breakfast during the MS Tram at Sunnybrook Park and served root beer floats for the Humane Society's golf tournament. In August the Pie and Ice Cream Social (part of the Rotary Corn and Chicken Feed) was held. We were lucky enough to once again sell out of our pies. In October, the youth helped with the Trunk or Treat event in the church parking lot. In November, six middle school youth along with Elana and Roger Seibert attended the Middle School Youth Gathering at Luther Crest Bible Camp. Another November event was the Thank You Thanksgiving Dinner. The event was moved to 11:00 and a silent auction was added. Dear Beloved in Christ of the Northwestern Minnesota Synod,

This message is written in the season of Advent, a season I have loved since I was old enough to know that there were seasons. There is something about this season's mix of melancholy and hope, darkness and light, that resonates with me. Children are central to the stories of Advent and Christmas – both in their preciousness and in their vulnerability. Every parent knows the agonizing mix of hope and fear that we carry for our children. As I write this, there is a devastating war happening in the land where the stories of our faith unfolded. And tragically, this war's devastating cost is landing mostly on children. "A voice is heard in Ramah, weeping and great mourning, Rachel weeping for her children...". (Matt 2:16). Join me in praying every day for a just peace in the lands of Israel and Palestine and for protection of the children.

As a parent and now grandparent, I know that the most desperate prayers we pray are for our children. When I visit congregation members and leaders across the synod, one deep question is always lurking: "What will our children's and grandchildren's experience of church be?" What I have learned is that making it about our kids means making it about faith in Jesus, plain and simple. We must give up needing our kids' experience of church to be like ours was, and instead pray for and work toward a church where children simply have a deep faith in Jesus Christ and a community of faith that loves them. It's back to basics! Back to basics often involves letting go of cherished traditions, buildings and ways of doing things that may have worked for us, but now only hinder us from focusing on growing our and our children's faith.

So, much of our work this last year has and will continue to focus on how to become a church where a child's faith can grow. This does not mean throwing programs and events at our kids, hoping something sticks. IT MEANS MAKING OUR LIFE TOGETHER ABOUT OUR FAITH IN JESUS and then generously, freely and often, sharing our faith with our children. Jesus-loving adults are the force that shapes the faith of children. This means freeing up communities to expend less energy on "keeping this thing going," and much more on hearing the gospel, praying, dwelling in God's word, serving the neighbor and seeking Jesus in our everyday life.

Hence, this year has been filled with hard and focused work of continuing to build out a robust network of support and accountability for lay ministers who serve in Word and Sacrament ministry under the mentorship of a seminary-trained, ordained pastor. Our process for vitality of smaller member congregations, "Rural Revival," has drawn us deeply into finding right-sized ways of providing word and sacrament ministry tailored to the unique needs of each community. While neither of these efforts look like "youth ministry," they really are because they free people to be more focused on the basics, more focused on following Jesus. ANY church that is focused on following Jesus is a church that is for the children.

So that is my simple appeal to you as you gather for your annual meetings this year. Let's make it all about being Jesus-followers sharing our faith with everyone, starting with our children.

REPORT OF THE ENDOWMENT FUND

The Mission Endowment Fund was established in 1996 as a depository for memorials, honorariums, planned gifts, 70 1/2 IRA withdrawals, and as a beneficiary of an estate. The purpose of the Fund is to enhance and extend the mission of Immanuel Lutheran Church apart from the general operation of the congregation. Gifts to the Endowment Fund are invested, not spent. Only the interest is used to further the church's mission. From our income a minimum of 51% will be used for outreach, such as a grant to mission work, ELCA seminaries or colleges or new congregational development. A maximum of 20% will be used for Immanuel's capital improvements, debt reduction or building program. A maximum of 29% may be used for emergency needs such as building repair or replacement of essential equipment.

This year, in addition to \$20225 of gifts, the fund received another gift of North Dakota farmland, which we sold for the sum of \$130000. These proceeds were invested in brokered CDs with Ameriprise financial (\$50,000), and a Term Investment with the Mission Investment Fund ELCA (\$80,000). With these gifts, our Endowment Fund took another significant leap forward and we are poised to make substantial gifts from the interest in the coming years.

You can be part of this exciting ministry by making a gift of any size to the Endowment Fund in 2024. The congregation is also encouraged to provide ideas and requests for ministry grants.



Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.


Receive our prayer, O God.
