Wednesday, January 29, 2025

President Mike Brunsberg called the 2024 Annual Meeting to order at 6:30 pm. Pastor Nate Loer welcomed everyone and gave an opening devotion by reading the letter included in the Annual Report from Rev. Elizabeth Eaton, Presiding Bishop of the ELCA.

OFFICERS REPORTS: The 2024 Annual Meeting minutes and reports including Council President, Treasurer, Financial Review for 2024 were presented as written in the Annual Report. A motion was made by Dean Krogstad and seconded by Diane Breitling to accept the reports. Motion Carried.

ROSTERED STAFF REPORTS: Pastor Nate thanked Mike Brunsberg for his service and leadership over the past year. He also thanked the outgoing council members, current staff members, musicians, choir members and director, Wednesday worship team and the congregation for the privilege of serving as pastor. Warner Luoma thanked Pastor Nate and Elana Seibert for their work with Parish Education. A motion was made to accept the rostered reports by Deb Haraldson and seconded by Les Breitling. Motion carried.

COMMITTEE REPORTS: The annual reports for Worship and Music, Finance, Congregational Life, Outreach/ Evangelism, Property Management and Youth were presented for review. There was no Parish Education report. A motion was made by Rick Johnson and seconded by Karen Leverington to accept the Committee Reports. Motion carried.

OTHER REPORTS: The reports from Immanuel Church Women, Women's Financials, Lutheran Men's Ministry, Memorial and Endowment Funds were presented for review. Pastor Nate briefly related where gifts had been made and the need for additional ideas for future gifts. A motion was made to accept the reports by Margie Anderson and seconded by Les Breitling. Motion Carried.

SYNOD REPORT: The letter from Bishop Tesch was presented. Briefly discussed was the work of the Synod and the Jeremiah 29 project which is a three year endeavor. Anyone from Immanuel interested in being on the Steering Committee for this project is encouraged to contact Pastor Nate.

OLD BUSINESS: President Mike Brunsberg thanked Pam Nelson for her work on completing the church directory which was recently published and distributed to church members. Pam Nelson thanked the members who had assisted with this project.

NEW BUSINESS: The church budget for 2025 was presented by Bryan Greenwaldt for discussion. Bryan thanked the congregation for their generous giving as well as Pastor Nate, church council and staff for their fiscal responsibility. After some discussion a motion was made by Warner Luoma and seconded by Les Breitling to amend the line item for Parish Education from \$2,500 to \$3,500. Motion carried. A second motion was made to approve the 2025 budget as amended by Warner Luoma and seconded by Joanne Link. Motion carried.

The report from the Nominating Committee was reviewed with the following names added for Financial Vice Secretary, Gail Kluenenberg, and Norm Gallant for the Nominating Committee. The chair of the Outreach Committee remains open. Motion was made by Amy Greenwaldt and seconded by Jane Erckenbrack to accept the slate of officers and close the nominations Motion carried. _____

Margie Anderson assumed the office of the president of the congregation and thanked Mike Brunsberg for his leadership during the past year. A motion was made by Shirley Hartjen and seconded by Gerald Leverington to adjourn. Motion carried.

The meeting adjourned at 7:30 pm with a closing prayer and the Lord's Prayer led by Pastor Nate.

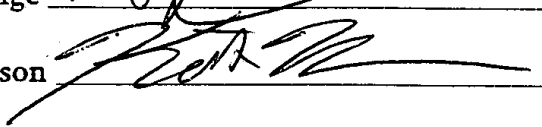

Dear beloved of God at Immanuel: Grace and peace to you in the name of our Lord, Jesus Christ.

I give thanks to God for another year of ministry and service to Immanuel as Lead Pastor. It is hard to believe that over 13 years have passed since I was first called to this congregation. And what a joy to reflect back on another fruitful year of ministry.

I love preaching and 2025 was another year full of opportunities to preach on Sunday mornings, Wednesday evenings, at funerals, and at weddings. I also cherish the calling to preside at Holy Communion and to preside at baptisms, too. I look forward to more opportunities to express God's love, mercy, forgiveness, and calling in 2026.

I also feel honored to walk alongside so many of you to provide counsel and spiritual care. So often in 2025, I had the privilege of being a listening ear (ears that wear hearing aids these days!), a prayer partner, a bearer of hope in the midst of your joys and struggles. REPORT OF THE ENDOWMENT FUND

The Mission Endowment Fund was established in 1996 as a depository for memorials, honorariums, planned gifts, IRA direct distributions, and as a beneficiary of estates. The purpose of the Fund is to enhance and extend the mission of Immanuel Lutheran Church apart from the general operation of the congregation. Gifts to the Endowment Fund are invested, not spent. Only the interest is used to further the church's mission. From our income, a minimum of 51% will be used for outreach, such as a grant to mission work, ELCA seminaries or colleges or new congregational development. A maximum of 20% will be used for Immanuel's capital improvements, debt reduction or building program. A maximum of 29% may be used for emergency needs such as building repair or replacement of essential equipment.

This year, we received total gifts of \$136,400 into the fund, including the gift of 120 acres of North Dakota Farmland, which we sold for \$130,000 (Those monies are currently invested with Ameriprise). We made disbursements totaling \$22,180.

You can be part of this exciting ministry by making a gift of any size to the Endowment Fund in 2025. The congregation is also encouraged to provide ideas and requests for ministry grants.

On entering the house, they saw the child with Mary his mother, and they knelt down and paid him homage. Then, opening their treasure chests, they offered him gifts of gold, frankincense, and myrrh.

-- Matthew 2:11

Dear Beloved in Christ of the Northwestern Minnesota Synod,

When the Magi first saw the child Jesus, their first instinct was to *pay him homage*. The word translated “homage” comes from the Greek *proskyneō*—from *pros* (“toward”) and *kyneō* (“to kiss”). Their worship was literally a *kiss toward Jesus*—a gesture of love, humility, and devotion.

That image captures what we long to be about in Northwestern Minnesota. Our vision—to be “a people wholly devoted to Jesus and our neighbor in love”—is another way of saying that we want everything we do together to be a kiss toward Jesus: a homage to the gentle One who heals, forgives, and sends us out in love.

This past year, our shared ministry offered many such kisses toward Christ:

- We **welcomed 15 new Synod Authorized Ministers**, ensuring that Word and Sacrament continue to touch lives in every corner of our synod.
- We **entrusted 14 new candidates for ordination**, nurturing leaders who will teach and serve in the spirit of Jesus’ humble strength.
- We **walked with congregations in transition and conflict**, showing that reconciliation itself can be an act of homage.
- We **sparked renewal** in rural congregations through our *Rural Revival Journey*, breathing hope and fresh imagination into places where Christ’s light still shines bright.
- And through *Jeremiah 29* and *F.A.C.E.S. of Leadership*, we are **equipping 41 leaders** to guide their communities toward deeper devotion—a daily kiss toward Jesus.

Friends, thank you. Your prayers, offerings, and faithful witness make these stories possible. Every kindness shared in Jesus’ name, every act of generosity, is another kiss toward the Savior we adore.

And in a time when Jesus’ name is sometimes used to divide us from one another or demean vulnerable neighbors, let us be clear about the One we worship. We pay homage not to a Lord of domination or fear, but to the humble Christ who welcomes the stranger, lifts the poor, blesses our most vulnerable siblings and honors the image of God in every person. The world has seen that kind of power come and go. The Magi journeyed far to worship a different kind of king—the one who reigns through mercy, not might.

As this year draws to a close, I invite you to join me in one more act of homage—a gift that becomes a kiss toward Jesus. Your congregation’s support and your personal generosity sustain ministries that bear Christ’s love to every corner of Northwestern Minnesota.

May our every gift, and every act of love, be a kiss toward the One who reigns from a manger and calls us to follow him in humility, justice, and joy.
